- I understand that there will be a pre-test (25 questions) prior to the learning module and a post-test (50 questions) after the learning module. The pre-test and the learning modules are self-paced, but must be completed within the scheduled window. The post-test is a one hour timed test. I must pass the post-test with a score of at least **80%**.
- I understand that if I fail to pass the post-test the first time, I will be allowed to retake the test one time after completing the learning module a second time. This retesting must be completed and passed within the scheduled window in order to move on to the applied portion of the testing. If I do not pass on the second attempt, **I must re-register for and retake the course again as a NEW JUDGE.**
- I understand I must attend the live applied test webinar and pass with a score of **60%** or greater. Judges who do not pass the applied test must reregister for and retake the course again.
- All **NEW JUDGES** will be required to complete **ONE APPRENTICE MEET PER DICIPLINE**. An apprentice meet is defined as 3 hours of judging. The apprentice judge is required to observe the meet, cannot delay the meet, dress appropriately and is **NOT** paid. Multiple disciplines may be completed in one day.

- I understand that upon completion and passage of judging and applied tests, I will be expected to pay \$40.00 for my NTJC number or my name will not be added to the active judging list and I will not be allowed to judge until dues are paid for. I will also need to pass a background check every 2 years (\$28) and complete the safe sport test prior to receiving my NTJC number.
- I understand that upon completion and passage of judging tests, I will need to purchase a set of flashers for \$20.00 to use at meets that I am contracted to judge. Flashers can be purchased through the NTJC Membership Coordinator, Eleanor Nicoulin, 4354 Accomack Drive, Louisville, KY 40241. 502-744-3731.
